**ANNUAL ACTION PLAN AMENDMENTS**  
**PUBLIC NOTICE**

**May 1, 2023**

The U. S. Department of Housing and Urban Development (HUD) requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submits, in a single application for funding, its request for Community Development Block Grant (CDBG), Emergency Solutions Grants (ESG) and HOME Investment Partnerships (HOME) Program Funds. Other funding addressed includes the Neighborhood Stabilization Program (NSP) I and III and Community Development Block Grant – Disaster Recovery (CDBG-DR), Community Development Block Grant – Coronavirus (CDBG-CV) and Emergency Solutions Grants – Coronavirus (ESG-CV) Funds. This strategy document is called the Consolidated Plan, and the single application for funding is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 30-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

**2017 CDBG Funding:**

Project 2017.026 Harris County Community Services Department- Health and Safety Home Repair Program (Countywide). Deobligate \$56,090.65. Project completed. Total project funding, including previously awarded amounts, will be \$143,909.35.

**2019 CDBG Funding:**

Project 2020-037 The Harris Center for Mental Health and IDD-CCHP Behavioral Health Response Team (COVID-19)(Countywide). Deobligate \$138,307.56 in 2019 CDBG Funds. Project completed. Total project funding, including previously awarded amounts, will be \$761,692.44.

**2020 CDBG Funding:**

Project 2020-038 Career and Recovery Resources, Inc.-CCHP Bridge to Permanent Supportive Housing (PSH) Case Management (COVID-19)(Countywide). Deobligate \$237,492.15 in 2020 CDBG Funds. Project completed. Total project funding, including previously awarded amounts, will be \$325,355.85.

**2022 CDBG Funding:**

Project 2022-011 Harris County Community Services Department- Harris County Single Family Program (Countywide). Obligate \$1,917,849.82 in 2022 CDBG Funds. Total project funding, including previously awarded HOME Funds \$2,736,223.27 (2017 prior year funds of \$42,284.30, 2019 prior year funds of \$693,938.97 and current year funding of \$2,000,000.00), total project will be \$4,654,073.09.
