Harris County Community Services Department ANNUAL ACTION PLAN AMENDMENTS PUBLIC NOTICE

March 7, 2022

The U. S. Department of Housing and Urban Development (HUD) requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submits, in a single application for funding, its request for Community Development Block Grant (CDBG), Emergency Solutions Grants (ESG) and HOME Investment Partnerships (HOME) Program funds. Other funding addressed includes the Neighborhood Stabilization Program (NSP) I and III and Community Development Block Grant – Disaster Recovery (CDBG-DR), Community Development Block Grant – Coronavirus (CDBG-CV) and Emergency Solutions Grants – Coronavirus (ESG-CV) funds. This strategy document is called the Consolidated Plan, and the single application for funding is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 30-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

2019 CDBG Funding:

C2019-029 Sheldon Road Municipal Utility District- Waterline and Fire Hydrant Improvements (Precinct 1). Deobligate \$253,889.17 in 2019 CDBG Funds. Project is complete. Total project funding, including previously awarded amounts, will be \$321,576.83.

2018 CDBG Funding:

C2018-026 Harris County Precinct One- Airline Improvement District Zone 2 Lorino Street Sanitary Sewer Lines Project (Precinct 2). Deobligate \$329,260.25 in 2018 CDBG Funds. Project is complete. Total project funding, including previously awarded amounts, will be \$429,257.75.

Project C2018-028 Harris County Precinct Three Parks Department- Sand Canyon Park/Sidewalk Improvement Phase II (Precinct 4). Deobligate \$10,310.03 in 2018 CDBG Funds. Project is complete. Total project funding, including previously awarded amounts, will be \$994,689.97.

2017 CDBG Funding:

Project C2017-028 Precinct One- Airline Improvement District Zone 2 Sanitary Sewer Lines (Precinct 2). Deobligate \$47,888.11 in 2018 CDBG Funds. Project is complete. Total project funding, including previously awarded amounts, will be \$1,399,318.75.
