ANNUAL ACTION PLAN AMENDMENTS
PUBLIC NOTICE

March 14, 2023

The U. S. Department of Housing and Urban Development (HUD) requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submits, in a single funding application, its request for Community Development Block Grant (CDBG), Emergency Solutions Grants (ESG) and HOME Investment Partnerships (HOME) Program funds. Other funding addressed includes the Neighborhood Stabilization Program (NSP) I and III, Community Development Block Grant – Disaster Recovery (CDBG-DR), and Community Development Block Grant – Coronavirus (CDBG-CV) funds. This strategy document is called the Consolidated Plan, and the single funding application is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 5-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

2020 CDBG-CV:

Project 2020-041 BakerRipley - CCHP Diversion Case Management (COVID-19)(Countywide). Deobligate \$44,382.51 in 2020 CDBG-CV Funds. Project completed. Total project funding, including previously awarded amounts, will be \$117,053.49.

Project 2020-042 The Salvation Army of Greater Houston- CCHP-Diversion Case Management (COVID-19)(Countywide). Deobligate \$47,471.23 in 2020 CDBG-CV Funds. Project completed. Total project funding, including previously awarded amounts, will be \$204,952.13.

2020 CDBG-CV and CDBG-CV3 Funding:

Project 2020-047 Career and Recovery Resources, Inc.-CCHP -Housing Stability: Income Support (COVID-19)(Countywide). Deobligate \$71,889.84 in 2020 CDBG-CV Funds and deobligate \$101,191.85 in 2020 CDBG-CV3 Funds. Project completed. Total project funding, including previously awarded amounts, will be \$791,941.31.

2020 ESG -CV Funding:

Project 2020-031m The Salvation Army of Greater Houston-CCHP Diversion Case Management (COVID-19)(Countywide). Deobligate \$305,845.53 in 2020 ESG CV Funds. Project completed. Total project funding, including previously awarded amounts, will be \$1,226,811.11.

2020 ESG-CV and ESG-CV2 Funding:

Project 2020-031k The Salvation Army of Greater Houston-CCHP Bridge to Permanent Supportive Housing (PSH) Case Management/Navigation (COVID-19)(Countywide). Deobligate \$515,855.42 in 2020 ESG CV Funds and deobligate \$21,438.25 in 2020 ESG CV2 Funds. Project completed. Total project funding, including previously awarded amounts, will be \$2,920,911.69.

Project 2020-031n BakerRipley - CCHP Rapid Re-housing (COVID-19)(Countywide). Deobligate \$44,421.01 in 2020 ESG-CV Funds and deobligate \$247,555.15 in 2020 ESG-CV2 Funds. Project completed. Total project funding, including previously awarded amounts, will be \$2,596,530.84.

Project C2020-0031o Career and Recovery Resources - CCHP Rapid Rehousing (COVID-19)(Countywide). Deobligate \$99,314.38 in 2020 ESG CV Funds and deobligate \$83,837.87 in 2020 ESG-CV2 Funds. Project completed. Total project funding, including previously awarded amounts, will be \$1,311,847.75.

2020 ESG-CV2 Funding:

Project 2020-0311 BakerRipley - CCHP Diversion Case Management (COVID-19) (Countywide). Deobligate \$55,162.22 in 2020 ESG-CV2 Funds. Project completed. Total project funding, including previously awarded amounts, will be \$1,439,837.78.
