

**Harris County Housing & Community Development seeks community Public Comments for the 2024-2028 Consolidated Plan, Fair Housing Assessment & 2024 Annual Action Plan**

**Public Notice**  
**July 5<sup>th</sup>, 2024**

Harris County Housing & Community Development (HCD) will hold two public hearings to solicit comments on the department's five-year 2024-2028 Consolidated Plan, Fair Housing Assessment, and 2024 Annual Action Plan.

The U.S. Department of Housing and Urban Development requires that Harris County develop a 5-year strategy document known as the Project Year (PY) 2024-2028 Consolidated Plan, which outlines the community development and housing goals for the jurisdiction over the next five years. This document includes the county's Fair Housing Assessment. Additionally, HCD must submit the PY2024 Annual Action Plan (AAP), an annual single application for funding for the Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), HOME Investment Partnership (HOME) grant funds, and other grants.

The PY2024-2028 Consolidated Plan, Fair Housing Assessment, and PY2024 AAP are available for public review and comment either online at <https://csd.harriscountytexas.gov/Programs/Plans-and-Reports/Consolidated-Plan> or at 8410 Lantern Point Dr., Houston, TX 77054 during normal business hours from July 5, 2024 at 10 AM and ending on August 7, 2024 at 5 PM. Comments must be submitted by August 7, 2024 no later than 5 PM.
