ANNUAL ACTION PLAN AMENDMENTS  
PUBLIC NOTICE

August 3, 2020

The U. S. Department of Housing and Urban Development (HUD) requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submits, in a single application for funding, its request for Community Development Block Grant (CDBG), Emergency Solutions Grants (ESG) and HOME Investment Partnerships (HOME) Program funds. Other funding addressed includes the Neighborhood Stabilization Program (NSP) I and III, Community Development Block Grant – Disaster Recovery (CDBG-DR), Community Development Block Grant – Coronavirus (CDBG-CV) and Emergency Solutions Grants – Coronavirus (ESG-CV) funds. This strategy document is called the Consolidated Plan, and the single application for funding is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 5-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

**PY2019 ESG Funding:**

Project C2019-0031b Coalition for the Homeless of Houston/Harris County for The Way Home Rapid Re-Housing CMI (Countywide)- Deobligate \$51,750.47 in 2019 ESG Funds. Project is complete. Total project funding, including previously awarded amounts, will be \$138,548.53.

**PY2018 CDBG Funding:**

Project C2018-0037 Harris County Precinct 3: Sidewalk project (Waterford, Alief 6 and Danish) *Current project scope:* Harris County Precinct 3's Sidewalk project will to construct 5800 feet of sidewalk throughout target area #54 (Waterford), target area # 3 (Alief 6), and target area # 17 (Danish), which will benefit individuals who reside in Harris County and are of low-and-moderate income households. *Revised project scope:* Harris County Precinct Three Sidewalk project will construct 5,800 ft. of sidewalk throughout target area #54 (Waterford), target area # 3 (Alief 6), and target area # 17 (Danish), which will benefit individuals who reside in Harris County and are of low-and-moderate income households. The project will also construct approximately 3,900 ft. of sidewalk on the opposite side of Rio Bonito Rd. (Alief 6).
