# **PY2022 CAPER Executive Summary & Highlights**

# Introduction

Each year Harris County through the Harris County Community Services Department (HCCSD) must report on the use of U.S. Department of Housing and Urban Development (HUD) entitlement funds and actions in addressing the needs stated in the Consolidated Plan via the Consolidated Annual Performance and Evaluation Report (CAPER). The Harris County Program Year 2022 (PY2022) CAPER is the fourth annual performance report for the PY2019-2023 Consolidated Plan and describes progress made from March 1, 2022 to September 30, 2023 towards the goals set forth in that Consolidated Plan. Note, Harris County changed its program start from March 1<sup>st</sup> to October 1<sup>st</sup> in PY2022. In PY2022, Harris County received \$20,488,884 in Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME) and Emergency Solutions Grant (ESG) funds plus an estimated \$40,600 in program income for a total of \$25,689,8954 in available funding. All projects expended entitlement funds amounting to \$22,489,600 during PY2022, which includes prior-year funding. Highlights of performance accomplishments according to specific need categories include:

### <u>Housing</u>

Assisted 13 homebuyers with direct homeownership assistance expending \$268,237.51 of HOME funds. Rehabilitated 43 owner-occupied housing units and abated 23 lead-contaminated housing units occupied by low-income persons expending \$2,638,969.69 of CDBG funds. Provided 14 units of Tenant-Based Rental Assistance (TBRA) and provided 54 supportive housing renter-occupied housing units for the homeless expending \$4,640,369.41 of HOME funds.

### <u>Homelessness</u>

Assisted 6,785 homeless individuals and families with shelter, homeless prevention, rapid rehousing, case management and supportive services expending \$1,720,367.57 in ESG and \$1,583,855.71 in CDBG/CDBG-CV funds

The FY2022 Continuum of Care (CoC) collaborative application was submitted to HUD through a community ranking process that included dividing new and renewal projects into two separate tiers. The requested funding is for costs including leasing, rental assistance, supportive services, operating costs, and HMIS. The projects provide permanent housing, consisting of permanent supportive housing for homeless persons with disabilities and their families as well as Rapid Re-Housing for homeless families with children. All of the forty-two (42) projects from Tier 1 and one (1) renewal project from Tier 2 were funded for FY2022. The total amount for FY2022 CoC renewal projects in Houston/Harris County jurisdiction amounted to \$45,252,733 for Tier 1 renewal projects and \$951,884 for one new project. The total FY2022 CoC Award for Houston/Harris County totaled to \$46,204,617. See table below for ESG funded projects, services provided, number served, authorized and expended in PY22.

### Public Services

Assisted 3,927 low-income persons and expended \$6,053,119.85 in CDBG/CDBG-CV public service funding for youth and seniors, transportation services, health and mental health services, subsistence payments and services for abused and neglected children.

### Public Facilities and Infrastructure

Served 164 low-income persons with 15 completed water and sewer improvement projects, one flood drainage improvements projects, and one Street Improvements project. Two public facilities projects were completed in PY2022.

## Other Improvements

Assisted local communities by clearing 12 abandoned homes that contributed to slum and blight in the county.

# Other Non-Entitlement Program Accomplishments

Harris County has also received Federal Economic Recovery and Stimulus Funds through the Housing and Economic Recovery Act (HERA), which includes the Neighborhood Stabilization Program (NSP1) and the Dodd-Frank Reform Act, which includes NSP3. The County was also in receipt of CDBG Disaster Recovery Hurricane Ike and Dolly, and 2016 Flood Allocations, 2017 Hurricane Harvey (CDBG-DR) Program funds, and CARES Act funds. These grant funds helped to stabilize and/or stimulate the local economy and recover from federally declared disasters and/or recessions. The following is a summary of the accomplishments of the specific recovery programs administered during PY2022:

- <u>2016 Flood Allocation CDBG-DR Funds</u> In PY2022, Harris County completed the 2016 Flood CDBG-DR funding and closed out the grant contract.
- <u>2017 Hurricane Harvey CDBG-DR Funds</u> To date, the Disaster Recovery program has expended \$528.25 million in CDBG-DR funding on 495 flood repair reimbursements for single-family homeowners, rehabilitated or reconstructed 132 single-family housing units, developed or preserved 1,761 assisted affordable rental units, bought out 360 homes/businesses from flood risk areas and served 198,239 persons with improved infrastructure/public facilities.
- <u>Coronavirus Aid, Relief, and Economic Security Act (CARES ACT) Funds</u> In PY2022, HCCSD continued to expend special allocations of CDBG-CV and ESG-CV funds to prevent, prepare for, and respond to the coronavirus (COVID-19) through the CARES Act. The County expended \$974,386 in CDBG-CV funds and \$1,821,920 in ESG-CV funds for a total expenditure amount of \$2,796,306. In PY2022, CDBG-CV expended \$810,789 on administration and project costs, and ESG-CV expended \$2,523,029 on administration costs.
- <u>HOME-ARP</u> In 2021, Harris County was allocated \$16,747,366 in Home Investment Partnerships Grant – American Rescue Plan (HOME-ARP) funds and \$2,516,154.90 was expended on administration and planning. In PY2022, the County completed the HOME-ARP Allocation Plan and it was approved by HUD. As stated in the HOME-ARP Allocation Plan CSD developed a request for applications/proposals for release in late September 2023 to carry-out the project activities outlined in the Plan.

As indicated by program accomplishments, Harris County continued to make strides in promoting affordable housing and providing a suitable living environment for its low-income citizens during PY2022.

# **Affirmatively Furthering Fair Housing**

As part of the PY2019-2023 Consolidated Plan, Harris County also completed a Regional Analysis of Impediments (AI) to Fair Housing Choice Plan. The AI Plan discusses actions taken over a five-year period to affirmatively further fair housing, overcome obstacles in meeting underserved needs, eliminate barriers to affordable housing, enhance coordination, and reduce the number of persons living below the poverty level. There were many opportunities for citizen participation and public comment throughout the development of the AI Plan. The AI Plan was built on citizen participation, cooperation, and collaboration that was an expression of community leaders, educators, developers, nonprofit workers, and government officials, and—most importantly—the views of residents living in Harris County's low-income communities. Harris County conducted over (20) community meetings, provided (3) different community surveys, and attended (12) community events, and distributed information and discussed the communities needs and priorities for Harris County. The AI Plan was submitted along with the PY2019-2023 Consolidated Plan and the PY2019 Annual Action Plan to HUD on May 17, 2019.

# Compliance

Regarding the administration of HUD entitlement funding, HCCSD has worked diligently to comply with HUD regulations and monitoring guidelines. Annual accomplishments are monitored to determine progress towards Consolidated Plan goals and objectives. Staff actively monitors grant funding account balances, expenditures for timeliness, and submits project data in the Integrated Disbursement and Information System (IDIS). HCCSD will continue to work with HUD to increase the efficient use of federal funds to serve low-income residents in Harris County.

The CAPER is due to HUD 90 days after the end of the program year by December 29,2023.

# PY2022 CAPER Highlights

The Program Year 2022 Consolidated Annual Performance and Evaluation Report (CAPER) describes Harris County's use of Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME) and Emergency Solutions Grant (ESG) funds, which are grants generated by tax dollars to improve the quality of life for county residents. Accomplishments reported in this document were made between March 1, 2022 and September 30, 2023. These accomplishments were made within the Harris County service area, which includes unincorporated Harris County and a variety of small cities within the county that have signed cooperative agreements of service with Harris County. These small cities are referred to as Cooperative Cities. The cities of Houston, Pasadena, and Baytown utilize their own community development resources and therefore are not within the Harris County service area. All Harris County U.S. Department of Housing and Urban Development (HUD) entitlement resources are dedicated predominantly to improve living conditions for low-income individuals and reduce slum and blight.

# Why is the CAPER Important?

Simply put, a large majority of resources discussed within the CAPER either directly or indirectly

flow from tax dollars. This alone warrants a need to use funds and other resources as wisely and prudently as possible. The CAPER reports to the general public and HUD the actual method in which resources were made available for use. In so doing, it provides an additional forum for community input into the community development process. The CAPER also ensures accountability by providing a detailed account of the provision of services by Harris County. Equally important is the fact that the CAPER is an evaluation instrument. It provides a summary of Harris County's performance as a HUD entitlement fund service provider, complete with strengths and weaknesses. It requires the participating jurisdiction to conduct a self-assessment, asking the questions: How well did the county utilize its HUD resources? Could more people have been served? Further, the CAPER provides a means by which HUD can ensure that agencies pursue and attain the proper and efficient use of resources.

The CAPER includes 1) a table of Consolidated Plan Annual Progress, 2) a summary of accomplishments, 3) an assessment of performance, and 4) a discussion of citizen participation. Each topic is developed so that the process is understandable to members of the general public. For PY2022, Harris County received funds through three formula grants issued by HUD: Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and the HOME Investment Partnerships Program (HOME). Projects and partnerships funded through Harris County programs often include substantial public and private funds leveraged to maximize success. The City of Houston Housing and Community Development Department was responsible for the administration of the region's Housing Opportunities for Persons with AIDS (HOPWA) allocation. In total, Harris County received \$20,488,884 in CDBG, HOME and ESG funds plus an estimated \$40,600 in program income for a total of \$25,689,8954 in available funding for PY2022. All projects expended entitlement funds amounting to \$22,489,600 during PY2022, which includes prior-year funding.

# Accomplishments According to Consolidated Plan Need Areas

One of the primary functions of the CAPER is to report on an entitlement community's annual efforts to implement its Consolidated Plan. Implementation of the Plan is measured through the accomplishments attained through projects and programs implemented during the program year.

However, due to the extraordinary circumstances encountered over the past three years with the COVID-19 Pandemic, Harris County communities and subrecipients have encountered a host of challenges. Many of our funded programs that provided needed services for the homeless, children, seniors, and low-income residents were forced to suspend, cancel or delay their programs due to COVID-19 social distancing and stay-at-home protocols, which resulted in delays in meeting year-end accomplishments and expenditures for Program Year 2022.

Table 1 summarizes Harris County's PY2022 efforts including accomplishments according to the needs and strategies reported in the Harris County 2019-2023 Consolidated Plan. The priority needs areas stated in the Consolidated Plan include: Public Facilities and Improvements, Economic Development, Homelessness, Housing, Other and Planning, Infrastructure, and Public

Services.

# Affordable Housing Accomplishments

Furthering affordable housing encompasses one of the primary purposes of HUD and is, therefore a major component in reporting and evaluating performance. The tables below summarize Harris County's efforts to further affordable housing during PY2022. These achievements utilized CDBG and HOME funds to promote the availability of affordable housing and increase the amount of decent, safe housing stock. Table 2 identifies affordable housing accomplishments by persons, housing units, and amounts authorized and expended. Table 3 identifies housing accomplishments by race and ethnicity.

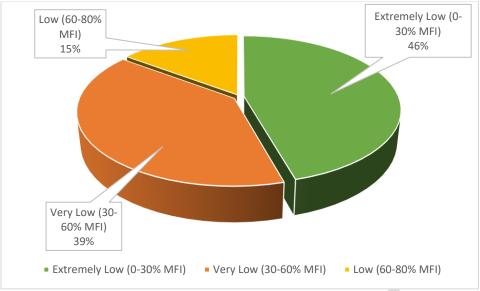

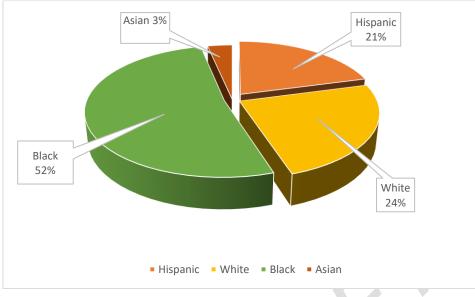
According to Chart 1 and Table 3, Housing Accomplishments According to Income, of the 149 households that received housing assistance, 46 percent were extremely low-income (0-30%), 39 percent were very low- income (30-60%), and 15 percent were low-income (60-80%).

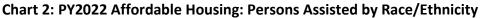

According to Chart 2 and Table 4 Affordable Housing Persons by Race and Ethnicity, out of the 149 persons receiving housing assistance in PY2022, 52 percent are Black, 24 percent are White, 21 percent are Hispanic, and 3 percent are Asian. HCCSD provided these persons with direct

homeownership, housing construction, housing rehabilitation, lead-based paint abatement, and tenant-based rental assistance.





## **CDBG Specific Accomplishments**

CDBG funds, which include the majority of Harris County entitlement funds reported in this document, were established to provide eligible services and other activities specifically for improving the quality of life for low-income persons. This section of the CAPER is dedicated to summarizing CDBG program accomplishments in community development areas of eligible activities that include public services, public facilities and infrastructure, housing, homelessness, economic development, and clearance and demolition.

### Public Services

CDBG/CDBG-CV public service projects primarily benefited low-income limited residents and programs that primarily benefit persons who are elderly, disabled, youth, receive transportation assistance, or may be abused or neglected children. According to Table 5, these projects expended \$6,053,119.85 and 3,927 persons were assisted in the PY2022 CAPER.

### Public Facilities and Infrastructure

Public facilities and infrastructure projects primarily consisted of the construction and renovation of public buildings that served a majority low-income area or a low-income limited clientele, and public works improvements located within low-income areas. According to Table 6, \$10,911,937.25 was expended on public facilities and infrastructure projects.

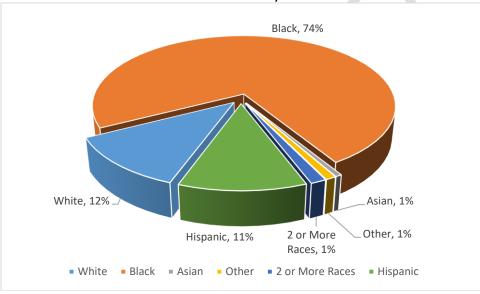

## Housing and Homeless

Under housing, Harris County expended \$2,688,320.75 in CDBG and HOME funds to serve 68 households with minor or major home repair, health and safety home repair, and lead-based paint abatement. Of that total, 38 were female head of household, 50 were elderly and 6 were disabled households in Harris County. Harris County also expended the remaining HOME funds on Tenant Based Rental Assistance (TBRA) for housing for 14 homeless individuals, families and youth aging out of foster care in Harris County. Of that total, 0 individuals were disabled and 8 were female head of household. Harris County expended \$268,237.51 to provide Downpayment Assistance for 13 clients of which 11 were female head of households.

Under homeless, Harris County expended \$1,583,855.71 in CDBG/CDBG-CV funding on 17 projects that served 3,261 homeless persons in PY2022. These services included homeless prevention services, dental restoration, and housing stability case management. Chart 3 identifies CDBG Homeless Race and Ethnicity. Note that homeless services were reported under the matrix code 03T Operating Costs of Homeless programs and 05M Health Services.

## **Clearance and Demolition Activities**

In PY2022, Harris County funded three projects through Harris County Public Health to conduct clearance and demolition of abandoned residential structures in the service area. The county expended \$163,488.06 in CDBG funds and 12 structures were demolished.

# **ESG Specific Accomplishments**

Authorized by the Stewart B. McKinney Homeless Assistance Act of 1987, as amended, the ESG program funds activities to expand and improve emergency shelter, outreach and engagement, rapid re-housing, essential services, and prevention services for individuals and families who are homeless or at risk of homelessness. During PY2022, Harris County authorized \$1,074,551.98 and expended \$749,263.07ESG dollars in assisting 3,524 homeless persons with shelter, street outreach, and rapid rehousing. Table 8 identifies the ESG accomplishments by persons served, authorized, and expended in PY2022.

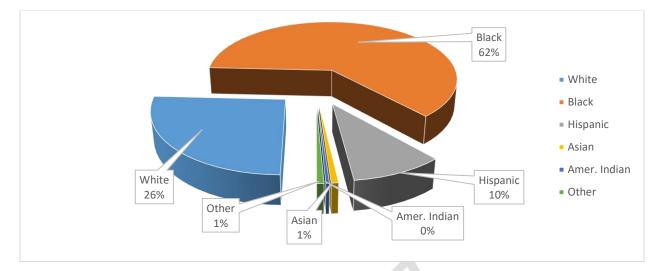
# **HOME Specific Accomplishments**

The HOME Investment Partnerships (HOME) Program was created under Title 11 of the National Affordable Housing Act of 1990, and funds activities to increase homeownership and affordable rental housing. For PY2022, HOME activities expended \$1,200,472.87 and assisted 70 low-income households with housing-related services, according to Table 10.
